Release of 1st grant.

Sanction of Science and Engineering Research Board (SERB) is hereby accorded to the above mentioned project at a total cost of Rs. 231000/- (Rupees Twenty Three Lakh Ten Thousand Only) with break up of Rs. 90000/- under Capital (Non-recurring) head and Rs.141000/- under General (Recurring) head for a duration of 36 months. 13. The project File no. EEQ/2017/003525 may also be mentioned in all research communications arising from the above project with due acknowledgement of SERB.


